Documents to be requested from foreign nationals

1) Certified copy of a diploma or graduation document; a notarized translation of the diploma or graduation document obtained from abroad and authentic or authenticated samples of the equivalence document obtained from the Higher Education Council,

2) Transcript; an authentic or official certified copy of the lecture notes and grades indicating graduation success grades; lectures and notes from foreign countries, authentic or certified copies of translations approved by the notary public,

3) C1 level document that they are successful in the Turkish exam made by ULUTÖMER, YEE or TÖMER. (Except those graduated from a higher education institution in Turkey). Candidates who do not have a C1 certificate are given 1 year to obtain this document.

4) Original or computer output of YDS or equivalent test result document. Must have received at least 55 points for Doctorate from International Foreign Language exams which are accepted by YDS or ÖSYM including foreign nationals. (English, German, French, Italian, Spanish, Russian, Arabic, Chinese, Japanese, Farsi) languages (Foreign language candidates must be outside their mother tongue.)

5) Passport; the passport of the visa is translated into Turkish, a notary certified example,

6) Residence permit; delivery to the Institute within one month from the date of the final registration of the original or officially certified copy of the residence permit to be issued from the provincial police headquarters,

7) Four newly taken 4.5x6 cm photographs,

8) The document showing that the fee determined by the related legislation is paid,

9) From the scholarship candidates, the authentic or official certified copy of the document to read scholarship,

10) Student registration form (to be obtained from the Institute's website)

11) Advisor preference form (to be obtained from the Institute's website)

Direct registration of foreign nationals placed in the framework of bilateral agreements made by the University or decisions of the Higher Education Council, except for the regulations concerning Turkish, can be made.

• Applications by post will not be accepted. Applications will be made "online".

• Candidates are required to submit the online application form to the members of the interview jury during the interview.

• Applications for the quoted quotations will only be made online, and information filled in during the online application will be accepted as a candidate's statement.

• Candidates are required to keep their transcripts (printed and certified) showing their undergraduate / graduate grade averages they have declared during the application, at the time of the interview and hand it over to the interview jury. Candidates who do not submit the transcript document to the interview jury will not be recruited. Applicants will be deemed null and void even if they have entered the interview.

• Candidates of foreign national who have no C1 level certificate of success in the Turkish examination by YEE and TÖMER are required to take the Turkish Proficiency Level Examination to be conducted by ULUTÖMER.

• Applicants may only apply to one of their graduate and non-thesis postgraduate or doctoral programs.

· Candidates should follow the application, interview and results through the system.

NOTE:

1-In the event of false or misrepresentation of false or falsified documents or falsified documents, applications will not be accepted, exact records will not be made and legal action will be taken.

2-According to the decision taken at the meeting of University Senate on 02.02.2017 in accordance with the Decree Law issued in the period of extraordinary state, the persons who were excluded from public office shall not be accepted as students to the universities of the University during the state of emergency.
