DECISION NO 1: The issue of Publication Conditions for the students of the Graduate Schools of Science, Health Sciences, Social and Educational Sciences of our university was started to be discussed.

At the end of the negotiatons; It was unanimously decided that the following conditions regarding the "Publication requirement of graduate students", which was jointly prepared by the Graduate schools of Science, Health, Social and Educational Sciences, were approved.

BURSA ULUDAG UNIVERSITY PUBLICATION CONDITION OF GRADUATE STUDENTS OF GRADUATE SCHOOL OF EDUCATION, SCIENCE, HEALTH AND SOCIAL SCIENCES

MASTERS DEGREE

- 1- There is no publication requirement for graduate students in the Graduate School of Social and Educational Sciences of our university. However, the scientific activities of the student within the scope of the Master's publication requirement of the Graduate Schools of Science and Health Sciences are taken into account in the doctoral entrance exam.
- 2- Graduate students who enroll in the Graduate Schools of Science and Health Sciences of our university as of the 2019/2020 Fall semester are required to meet at least one of the following requirements related to the thesis topic or the Department's program during their education.
 - a) Having at least one article published or accepted for publication in national/international peer-reviewed journals,
 - b) To have made an oral or poster presentation that has been presented at national/international refereed events and whose abstract or full text has been printed in the proceedings booklet,
 - Having worked as a researcher or scholar in a national/international project for at least 3 months,
 - d) To have documented the patent/utility model/industrial design for which the application has been made, or to have documented the architectural design or variety registration.
 - e) Being abroad for at least 2 months to work in the field (including education) with the support of Erasmus, Mevlana, Tubitak, YOK, professional institutions or the Rectorate.

DOCTORAL DEGREE

The Doctoral student, who is studying at the Graduate Schools of our University and has been in the course stage as of September 8, 2016, but has not passed the thesis stage; It must meet at least one of the "Conditions b" below, in addition to "Condition a".

a) At least one original research article published or accepted for publication in a journal indexed by the SCI, SSCI, AHCI or SCI-Expanded indexes for the Graduate School of Science and Health Sciences of our University;

At least one original research article published or accepted for publication in a journal indexed by SCI, SSCI, AHCI, SCI-Expanded indexes or indexed by TR-index for the Graduate Schools of Social and Educational Sciences of our university (PhD students who are registered before the Fall Semester of 2019/2020 in theGraduate Schools of Social and Educational Sciences of our University and who are at the course stage as of September 8, 2016 and have not passed the thesis stage, the publications of in a journal that are indexed by other international indexes or published by other Public Universities also meet the publication "condition a" in the doctoral publication requirement (Since the A1.3 publication is accepted under the current conditions in the year the student is registered.);

b)To provide at least one of the following activities in addition to the research article in item "condition a"

- b1) Having at least one research article published or accepted for publication in national/international peer-reviewed journals,
- b2) Having an oral presentation with the abstract or full text printed in the proceedings booklet presented in national/international peer-reviewed events,
- b3) Having worked as a researcher/scholarship in a national (Tubitak or BAP)/international project for at least 3 months,
- b4) Having documented the registered patent/utility model/industrial design or documenting the architectural design or variety registration
- b5) Being abroad for at least 2 months to work in the field (including education) with the support of Erasmus, Mevlana, Tubitak YOK, vocational institutions or the Rectorate,
- b6) For Fine Arts Majors and Fine Arts Education Divisions; With an international jury (selective committee); Participating in an art event that includes competitive exhibitions, biennials and triennials with his work and this work has been published in a printed or electronic catalogue, or it has been awarded in juried art events.

The Board of Directors of the Graduate Schools is authorized to implement this Senate decision (determination of principles, necessary documents, etc.).

With this Senate decision, decision no. 5 taken by Bursa Uludag University Senate on the publication requirement at the Senate meeting dated January 31, 2019 and decision no. 1 taken at the Senate meeting dated September 8, 2016 were repealed.

For students who have passed the thesis stage as of September 8, 2016, the rules on the date of registration are valid.
