There is also an Occupational Health and Safety Coordination Office for academics.

#### In this context:


- Providing Occupational Health and Safety (OHS) trainings to all staff and students through face-to-face or interactive methods in accordance with the regulations,
- To ensure the health and safety of all stakeholders (academic and administrative staff, students, interns, visitors and subcontractors), to take all kinds of measures in accordance with national legislation, to inform all stakeholders and to supervise the measures taken,
- Adoption of an OHS process management system in which all academic and administrative units within the university can act in coordination on occupational health and safety issues,
- Carrying out risk assessment studies in a proactive approach to identify risks that will affect all stakeholders within Bursa Uludağ University,
- To be always ready for emergencies and to raise the awareness of all our stakeholders effectively,
- Investigating the root causes of near misses, occupational accidents and occupational diseases in detail and taking effective measures to prevent them from happening again,
- Periodic health examinations of all our academic and administrative staff,
- Establishing effective systems for periodic control of all work equipment within Bursa Uludağ University,
- As Bursa Uludağ University, to be in effective communication with all public and private organizations in our country on occupational health and safety,
- Creating working environments where all our stakeholders will be physically and mentally healthy and safe,
- Occupational health and safety are recognized as the fundamental principles of our policy.

# **Access to Mental Health Support**

According to Article 5 of the "Bursa Uludağ University Faculty of Medicine Student Counseling Directive", there is a "Board of Advisors" consisting of the Vice Dean responsible for education, one faculty member from Basic Medical Sciences, Internal Medical Sciences and Surgical Medical Sciences, one faculty member from the Department of Psychiatry, one faculty member from the Department of Medical Education and one clinical psychologist. In addition to this institutional structure, a "Student Psychological Counseling Office" has been established within USIM, where clinical psychologists are assigned. Appointments are made through the MIAMED system through the USIM Secretariat for the office, which provides regular services to students on Tuesdays and Thursdays.
